Bibliografia niniejsza jest kontynuacją wykazu sprzed dwudziestu laty (zob. W. Niedźwiecki, *Didache. Nauka Dwunastu Apostołów (Bibliografia 1883-2000)*, „Vox Patrum” 22 (2002) s. 639-664). Przy tej okazji warto nadmienić, że na 2023 rok przypada 150. rocznica odnalezienia greckiego tekstu *Didache* przez metropolitę Philotheosa Bryenniosa i 140. rocznica wydania przez niego tego dzieła jako *editio princeps*: Διδαχὴ τῶν δώδεκα ἀποστόλων ἐκ τοῦ ιεροσολυμιτικοῦ χειρογράφου νῦν πρῶτον ἐκδιδομένη μετὰ προλεγομένων καὶ σημειώσεων, ἐν οἷς καὶ τῆς συνόψεως τῆς παλαιᾶς διαθήκης, τῆς ὑπὸ Ἰωάνου τοῦ Χρυσοστόμου, σύγκρισις καὶ μέρος ἀνέκdoton ἀπὸ τοῦ χειρογράφου, ὑπὸ Φιλοθέου Βρυεννίου μητροπολίτου Νικομηδείας, Ἐν Κανστατινουπόλει: τύποις Σ.Ι.
