1. IX KOLLOKWIUM W BIRMINGHAM NA TEMAT KRYTYKI TEKSTUALNEJ NOWEGO TESTAMENTU

W związku z projektem Europejskiej Rady Badań COMPAUL (realizującym badania nad wczesnymi komentarzami do Listów św. Pawła jako źródłem biblijnego tekstu) Uniwersytet w Birmingham zorganizował w dniach **2–5 III 2015 r.** **Dziewiąte Colloquium pt. *Krytyka tekstualna Nowego Testamentu*** (*Ninth Birmingham Colloquium on the Textual Criticism of the New Testament*). Obrady miały miejsce w Orchard Learning Resource Centre i Selly Oak Campus w Birmingham w Wielkiej Brytanii.
